Why Revisit No Turning Back

- Original study was carried out in 2010
- Environment has changed politically and financially
- There have been developments within our Industry
- But has there been change and how much?



What No Turning Back Argued

- We needed Leadership from WAG and Core Public Sector decision makers
- We needed improved and consistent tendering processes
- We needed adhering to Policy of Best Value
- We needed a willingness for Government, Clients and Suppliers to work in an Integrated and Collaborative way.



Structure and Format of Review

- Set 2 basic Questions/Objectives
- Set 3 fundamental areas to review
- Set a series of questions per review area
- Consult with the Industry via direct meetings, phone interviews and electronic questionnaires
- Analyse results and report findings
- *Revisit No Turning Back Recommendations??*

- Do you consider Frameworks being procured are an option for delivering best value for clients and suppliers?
- Is there a consistent approach between Client Procurer and delivery teams?



- What Suppliers need to do
- Do you consider Suppliers are embracing cultural change towards collaborative working?
- Do suppliers cascade collaborative working down their supply chain?
- Are suppliers embracing the concept of quality/price requirements in tenders?
- Is the supply chain suited to best value or lowest price tendering?
- Does collaborative/best value tendering or lowest price provide suppliers with the most robust commercial outputs?
- Is there still a barrier to SMEs through best value quality based tendering?
- Are suppliers delivering better internal opportunities through training/recruitment from the use of collaborative project delivery?








Total Forward Programme 2014 /15 – 2017/18




Forward visibility trends (local authority time horizons)

- No LA providing only a one-year programme (2 last year)




Programme by Sector 2014/15 - 2017/18 Total = £2757m






Programme by Sector 2014/15 Total = £1079m




North Wales by Sector 2014/15 -2017/18 Total = £595m






Mid Wales by Sector 2014/15 – 2017/18 Total = £248m


South West by Sector 2014/15 -2017/18 Total = £770m
