Rt David Jones MP

Secretary of State for Wales

Rt Hon David Jones MP was appointed Secretary of State for Wales on 4 September 2012 having served as Parliamentary Under Secretary of State for Wales since May 2010. David was elected as Member of Parliament for Clwyd West in May 2005. Before becoming an MP, David was senior partner in his own legal practice based in Llandudno. In 2002 he replaced Rod Richards as Assembly Member for the North Wales Electoral Region. He stepped down at the 2003 Assembly election. At Westminster, David has held a seat on the Welsh Affairs Select Committee and was co-chairman of the Associate Parliamentary Sustainable Resource Group. He was appointed Shadow Minister for Wales in November 2006.
